1. APOLOGIES FOR ABSENCE

Apologies were received from CW&C Ward Councillor Deynem, PCSO Deborah Netherton and Manley Parish Councillors Pam Brook and Peter Sherlock.

2. ELECTION OF CHAIRMAN FOR THE COMING YEAR

Councillor Walton was elected as Chairman for 2022/23. This was unanimously agreed. Councillor Walton accepted the position of Chairman and signed the Declaration of Acceptance of Office form.

3. ELECTION OF VICE CHAIRMAN FOR THE COMING YEAR

Councillor Ford was elected as Vice Chairman for 2022/23. This was unanimously agreed.

8. HIGHWAYS

8.1 State of the Roads - Update on the status of the review of the roads

There has been some progress in improving the state of the roads, with Waterloo Lane receiving surface treatment and New Pale Road patched up in places.

The PC expressed concerns about the potholes around the village which seem to be getting worse. The PC are to log the potholes on the CW&C Highways Portal and the link is to be added to the website to encourage residents to also report any highway issues.

Action - All to log the potholes via the Cheshire West and Chester Council Highways Portal

9.1 Discuss the covenant on the Parish Field which prohibits alcohol consumption and gambling and agree a plan of action to see if these can be lifted.
